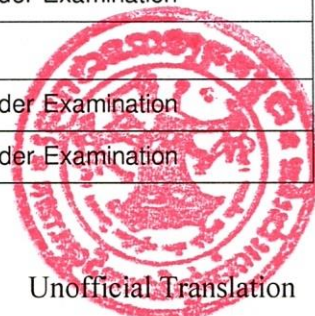

In accordance with the regulations and procedures for the 6th Legislature of the Election of Members of the National Assembly, Article 4.9 states that **NEC shall examine the applications for the registration of the political parties running for the election not later than 7 (seven) days after receiving the application.** If NEC finds that any party does not fulfil the requirements on the registration of the political party running for the election, NEC shall notify the concerned party accordingly to complete or modify its application and **the concerned party shall complete the missing requirements not later than 5 (five) days after the date of receiving the notice.**
